	2. DRC Rep from DPAC Beth asked Victoria to better let us know when meetings are going to happen. Until Policy is changed, we need to adhere to current policy and try to send a DPAC parent rep. Beth reported that Dr. Woudzia stated that the Board has not yet looked at the requested policy change. Discussion that parents should be told about the process and their rights and their right to bring an advocate.	Beth to write a letter articulating DPAC Executive concerns
	3. Playground Supervision by Parents Beth spoke with Dr. Woudzia several times about this issue. Priority is around bullying. Dr. Woudzia has not formally replied yet. Discussion about looking at what existing levels of supervision are like and could parent supervision be used to supplement. Discussed appropriateness of parent supervision on playgrounds – not all in agreement with concept of parent supervision. Questions as to whether our district supervision is lower than in other districts. Discussion whether SEA supervision happening at lunch and recess for children with IEP's. Dr. Woudzia recommends parents let the school administration know if children with IEP's are not getting appropriate supervision. Issue should be raised within the Special Needs Consultation but it is not just a special needs issue.	Beth to follow up with superintendant about whether parents could supervise on the playground. Beth to initiate further discussion around adequate supervision of children of all needs.
	Playground Equipment Funds Maya drafted a letter to the Ministry from DPAC regarding the need for play.	Maya to update letter with new information provided by Ronda Field
	5. Media Strategy Decision made that media queries for schools will be forwarded to school PAC Chairs or designates. Need for the DPAC Executive to develop a media strategy for district wide questions. Discussion that the DPAC Chair can only speak to the media on an issue when DPAC has had a discussion and taken a particular position on that issue. It is within our by-laws to have a media designate.
