1.7. Superintendent Report - District Update

COVID

- Notification process has changed. Notification letter includes self-isolation letter for class or students.
- Concerns around variants and increased transmission creating high degree of concern
- PHO data shows school transmission is flat compared to increase in community transmission
- School transmission does not appear to be driver for community transmission
- Cases are predominately VOC (Variants of Concern)

Budget

- The NW School District will have a structural deficit, expenses > revenues.
- Deficit is \$1.8M, on budget of \$70M
- Shortfall mainly due to 120 international students for 2020-2021 is short of our 200 students pre-covid
- \$3.8M district has a surplus that is part of our operating budget
- Priorities
 - We need to still allocate additional money for enhanced health-and safety
 - No plans to cut programs and services
 - Will not be able to spend all the other options
- We are the fastest growing metro school district in proportion, 3.8%
- Budget consultation is underway
- Areas that may not get new funding include: Supplies & resources/Collaborative learning spaces/furniture / adding additional counselling/staffing/additional administration

3.1. BCCPAC Update & Resolutions

- Speaker Proxy form must be filled out for anyone wishing to log on and check out the BCCPAC AGM. Forms need to be signed by 2 PAC executive members and sent in before Monday.

- Resolutions Thank you to Cyrus, Ronda, Beth and Sue Kenny for your help and support with the Resolutions we sent in. Please see below for resolutions sent in, and comments for each.

Below is the list of resolutions that DPAC submitted with response/feedback from BCCPAC.

- Resolution #1: Safe Water as a Human Right was changed to PENDING APPROVAL
 - This was changed to Safe Drinking Water for All K-12 Students in BC Public Schools
 - We are waiting to hear back regarding the new wording to this resolution.
- Resolution #2 Restricting the Sale of Bottled Water in Schools PENDING APPROVAL
 - We had to change this because the MoE has a policy regarding guidelines for the sale of food & beverages in schools. Change now reads: Be it resolved that BCCPAC advocate to the Ministry of Education to revise the Guidelines for Food & Beverage Sales in B.C. Schools (gov.bc.ca) to restrict the sale and use of single use bottled water in schools
- Resolution #3 Funding for new School Build / rebuilds to accommodate projected population growth - REJECTED
 - We were told this is a school board matter and new school builds are funded through the MoE's capital program. Funding a new build doesn't change except for parameters regarding size through the Area Standards Document. So, we sent in a new resolution below

- Resolution #3b Change to the BC Area Standards Document PENDING APPROVAL
 - This now reads be it resolved that BCCPAC advocate for revisions to the Ministry of Education Area Standards document for the design of all new or rebuilt schools throughout BC to have the necessary capacity to accommodate reasonable growth projections for future enrolment, instead of the current standard which is based on current enrolment numbers.
- Resolution #4 Restricting the sale and use of vapour products near schools REJECTED
 - We were told this is all about enforcement, I informed them it is about the
 distance between the point of sale and our schools. I was told this was not a
 provincial matter it is a municipal matter. We respectfully with-drew this
 resolution for this year. We would love to have others who have the time and
 energy to help out so we can put forth a resolution next year that will be
 accepted.
- Resolution #5 Development of MoE Climate Action Plan REJECTED
 - We did not get a lot of information on why, have done a lot of research and see that the MoE has an old plan that has not been updated. It also seems many districts are working on this. It makes sense to have all School Districts working together.
 - Dee reported the Trustees are putting forth a call for an action plan through the BCSTA (School Trustee Association) - we fully support this!
- Resolution #6 Publicly funded HPV Vaccine for All Students REJECTED
 - They rejected this based on information that they read regarding the Vaccine, saying it already exists, is free & is only required for other populations if deemed at risk. Also said this is not a BCCPAC mandate as we cannot influence what the Ministry of Health will or will not pay for.
 - After more back & forth I asked where we could advocate for the safety and inclusion of ALL students, we were told it would be to the Ministry of Health.
- Resolution #7 Funding for Provincial K-12 Online Education Program PENDING APPROVAL.

We sent this in, advocating for you, after hearing parents' concerns at our last DPAC meeting. There were a few small changes suggested; we are hopeful this will get approved to be voted on at the AGM
